Manager's Recommendation:

I recommend the approval of the Urban Cooperation Agreement with Kochville. The total amount of the Agreement is \$12,500. The term of the Agreement is for one year; however, the parties can extend the Agreement for individual terms of one year. The City Manager has approved the Agreement as to substance and the City Attorney as to form.

Justification:

Kochville Township contacted the City of Saginaw Inspection Division seeking the services to perform its Plumbing/Mechanical Inspections in December of 2015. The City makes its employees available for assignments in the Township for inspections on an as-needed basis. After review by staff, the volume of work has not impacted the services to Saginaw residents and has proven to be a mutually beneficial arrangement. Both the City and the Township have agreed to continue the arrangement and have further agreed to an increase in the annual fee as well as sharing in additional fees that the Township charges for additional inspections as required by their ordinances. The City employees will retain their full time positions with the City, including all salary, medical benefits, pension and other fringe benefits. In addition, the parties have agreed to mutually indemnify and hold each other harmless.

Subject: FY2017 Mid-Year Personnel Complement Staffing Adjustments

Manager's Recommendation:

I recommend approval of the following changes to the 2016 – 2017 Personnel Complement as reflected in the attached sheets. Such changes stem from efforts to structure employee job duties and responsibilities in such ways as to continue effective delivery of City services while attempting to monitor costs as appropriate.

Justification:

All job vacancies and pay grades are examined by the Management Review Team to ensure appropriate staffing levels at appropriate wages. This review shows both decreases and increases in wages for City employees, resulting in an overall increase in total wages of \$29,392. Of this total, General Fund wages increase \$13,319 and Non-General Fund wages increase \$16,073. There is no increase in staffing from July 1, 2016. Such adjustments now properly reflect the job assignments and levels of responsibility performed by City employees.

Manager's Recommendation:

I recommend approval of the Service Agreement between CBIZ Retirement Plan Services and the City of Saginaw. This agreement has been approved by me as to substance and the City Attorney as to form. It is also recommended that the City Council authorize the City Manager or his designee to sign all documents related to these agreements.

Justification:

The City of Saginaw is required under Governmental Accounting Standards Board (GASB) to have an Other Post-Employment Benefits (OPEB) Bi-Annual valuation completed.

GASB 45 for 2016 and GASB 75 for 2017, is an accounting and financial reporting provision requiring government employers to measure and report the liabilities associated with OPEB.

OPEB relates to benefits (other than pensions) that U.S. state and local governments provide to their retired employees. These benefits principally involve health care benefits, but also may include life insurance, disability, legal and other services.

CBIZ is an actuarial firm that will perform the complete OPEB valuation for the City of Saginaw. CBIZ Retirement Plan Services is based out of Kansas City, Missouri with a satellite office in Lansing, Michigan. CBIZ currently performs all the actuarial valuations for all of the other City of Saginaw Pension Plans.

The cost of the two year actuarial valuation is \$20,000 to be paid when services are completed.

This vendor meets all requirements of §14.23, "Vendors," of "Purchasing, Contracting, and Selling Procedure," of Chapter 14, "Finance and Purchasing," of Title I, "General Provisions" of the Saginaw Code of Ordinances O-1.

The funds are budgeted in the General Fund - Department of the General Government - Office of Human Resources', Labor Professional Services Account No 101-1725-809.000.

Manager's Recommendation:

I recommend that the low bid from Strahl, LLC of Woburn, MA be accepted and a purchase order be issued to them in the amount of \$8,290 for the purchase of a Pipe Inspection Micro-Camera to be used at various City of Saginaw locations.

Justification:

On December 27, 2016, the City received two (2) bids to purchase a Pipe Inspection Micro-Camera to be used at the City Hall, Public Works Buildings and Celebration Splash Park. The camera will be used for maintenance purposes to view roof and floor drain lines at City Hall and Public Works for damage and blockages, also at the Splash Park to view underground water and drain lines. The video camera will be very useful in helping to determine maintenance needs in existing infrastructure.

Subject: Easement Agreements & MOU – Davis Road Water System Improvements

Manager's Recommendation:

I recommend the easement agreements and "Memo of Understanding" (M.O.U.) for an associated total payment in the amount of \$400,714.60 between The City of Saginaw and parties indicated(see table) be approved and payments made. The Agreements and M.O.U. have been approved by me as to substance and the City Attorney as to form. It is also recommended that City Council authorize the City Manager or his designee to execute all related documents.

Justification:

As Council has previously been made aware, the City has been preparing for a raw water and transmission main replacement and relocation project on Davis Road between Pierce Road and Trautner Drive in Kochville Township. This is in advance of an upcoming 2018 Saginaw County Road Commission Project for Davis Road reconstruction.

A major portion and initial phase of the project was for the City to gain ownership or easement rights from the property owners along Davis Road to allow for the installation of the new water mains.

The City of Saginaw, along with its Attorney, William Smith and Spicer Group has been working with the property owners for many months in an effort to gain approval for the easements requested.

Appraisals were completed for each easement location by Piazza Appraisal Service, a licensed land appraisal company, prior to offers being made. Every effort was made to assure a fair equitable process and offer to these owners. Funds for the purchase of land for this project were included in and part of the overall bond for this Davis Road project. Project construction is estimated to start sometime late winter or early spring 2017 with completion in spring 2018 in advance of Saginaw County's Road reconstruction project.

The property's in which the easements are needed are owned by various individuals along the route. Some of the easement properties include MOU's due to disturbances or accommodations pertinent to the property. The MOU's have more detailed explanation of the disturbance or accommodations required. Those property owners which have signed the easement agreements and associated MOU's, are listed below along with

the total area of land required and amount of payment for each easement and or additional accommodation.

Manager's Recommendation:

Justification:

On December 20, 2016 the City received bids for the Davis Road Water Main Improvements Contract #1 (C-1635). The work to be performed is only at the intersections of Pierce Road and Davis Road, and Trautner Drive between Davis Road and Hampton Place. Contract #1 allows for the connection work to be completed prior to the main utility and roadway work so as to minimize construction inconvenience to neighboring roadways and entities.

Manager's Recommendation:

I recommend the property purchase and agreement between The City of Saginaw and Zestos Properties be approved and payment made in the amount of \$69,500.00, for approximately 0.88 acres of land, located at 5400 Trautner Drive in Kochville Township. The Agreement has been approved by me as to substance and the City Attorney as to form. Justification:

As Council has previously been made aware, the City has been preparing for a raw water and transmission main replacement and relocation project on Davis Road, between Pierce Road and Trautner Drive in Kochville Township. This is in advance of an upcoming 2018 Saginaw County Road Commission Project for Davis Road reconstruction.

A major portion and initial phase of the project was for the City to gain ownership or easement rights from the property owners along Davis Road to allow for the installation of the new water mains.

The City of Saginaw, along with its Attorney, William Smith and Spicer Group have been working with the property owners for many months in an effort to gain approval for this land acquisition.

The property purchase in this location is needed rather than an easement for the following reasons; site disturbance will be significant as it relates to relative property size, anticipated need for contractor construction staging area for storage of equipment and materials at southern end of project and expected property resale value for restored remaining property area after project completion.

An appraisal was completed for this property by Piazza Appraisal Service, a licensed land appraisal company, prior to offers being made. The property purchase was negotiated by the City's Attorney, William Smith and the project team including City Staff. The final agreed upon price was much less than the owner listed price of \$150,000, and assessor land value of \$126,941.

Funds for the purchase of land for this project were included in and part of the overall bond for this Davis Road project. Project construction is estimated to start sometime late winter or early spring 2017 with completion in spring 2018 in advance of Saginaw County's Road reconstruction project.

Funds for the land acquisition are budgeted in the Water Operations and Maintenance Fund, Water Refunding Bond's Division's, Operating Services Account No. 591-4741-805.000 for Fiscal Year 2017.

I recommend approval of the Performance Resolution agreeing to the requirements the City of Saginaw must follow in all applications for permits to perform work within the Michigan Department of Transportation (MDOT) State Highway Right of Way within the city boundaries.

Justification:

The Michigan Department of Transportation requires all municipalities that construct, operate, use and/or maintain utilities or other facilities, or conduct other activities on, over and under State Highway Right of Way, apply for an annual permit to perform the work, and to provide advance notification of the activity to the Michigan Department of Transportation.

The activities performed may include tree trimming and removal, water and sewer underground utility operations, aerial utility operations, banner installation, road closures and traffic control for special events, and detours on State Highway routes. MDOT requires a resolution from the municipality before they will issue permits.

The existing Performance Resolution was previously approved by City Council on January 24, 2015. The Michigan Attorney General requested the Performance Resolution be updated to reflect new language that protects MDOT liability coverage for municipalities that utilize contractors to perform their work.

The Performance Resolution shall continue in force from this date until cancelled by the City of Saginaw or MDOT with no less than thirty (30) days prior written notice provided to the other party.

PERFORMANCE RESOLUTION FOR GOVERNMENTAL AGENCIES

RESOLVED WHEREAS: the City of Saginaw hereinafter referred to as the "GOVERNMENTAL AGENCY," periodically applies to the Michigan Department of Transportation, hereinafter referred to as the "DEPARTMENT," for permits, referred to as "PERMIT," to construct, operate, use and/or maintain utility or other facilities, or to conduct other activities, on, over, and under State Highway Right of Way at various locations within and adjacent to its corporate limits;

NOW THEREFORE, in consideration of the DEPARTMENT granting such PERMIT, the GOVERNMENTAL AGENCY agrees that:

1. Each party to this Agreement shall remain responsible for any claims arising out of their own acts and/or omissions during the performance of this Agreement, as provided by law. This Agreement is not intended to increase either party's liability for, or immunity from, tort claims, nor shall it be interpreted, as giving either party hereto a right of indemnification, either by Agreement or at law, for claims arising out of the performance of this Agreement.
2. If any of the work performed for the GOVERNMENTAL AGENCY is performed by a contractor the GOVERNMENTAL AGENCY shall require its contractor to hold harmless, indemnify and defend in litigation, the State of Michigan, the DEPARTMENT and their agents and employee's, against any claims for damages to public or private property and for injuries to person arising out of the performance of work, except for claims that result from the sole negligence or willful acts of the DEPARTMENT, until the contractor achieves final acceptance of the GOVERNMENTAL AGENCY. Failure of the GOVERNMENTAL AGENCY to require its contractor to indemnify the DEPARTMENT, as set forth above, shall be considered a breach of its duties to the DEPARTMENT.
3. Any work performed for the GOVERNMENTAL AGENCY by a contractor or subcontractor will be solely as a contractor for the GOVERNMENTAL AGENCY and not as a contractor or agent of the DEPARTMENT. The DEPARTMENT shall not be subject to any obligations or liabilities by vendors and contractors of the GOVERNMENTAL AGENCY, or their subcontractors or any other person not a party to the PERMIT without the DEPARTMENT'S specific prior written consent and notwithstanding the issuance of the PERMIT. Any claims by any contractor or subcontractor will be the sole responsibility of the governmental agency.

4. The GOVERNMENTAL AGENCY shall take no unlawful action or conduct, which arises either directly or indirectly out of its obligations, responsibilities, and duties under the PERMIT which results in claims being asserted against or judgment being imposed against the State of Michigan, the Michigan Transportation Commission, the DEPARTMENT, and all officers, agents and employees thereof and those contracting governmental bodies performing permit activities for the DEPARTMENT and all officers, agents, and employees thereof, pursuant to a maintenance contract. In the event that the same occurs, for the purposes of the PERMIT, it will be considered as a breach of the PERMIT thereby giving the State of Michigan, the DEPARTMENT, and/or the Michigan Transportation Commission a right to seek and obtain any necessary relief or remedy, including, but not by way of limitation, a judgment for money damages.

5. The GOVERNMENTAL AGENCY will, by its own volition and/or request by the DEPARTMENT, promptly restore and/or correct physical or operating damages to any State Highway Right of Way resulting from the installation, construction, operation and/or maintenance of the GOVERNMENTAL AGENCY facilities according to a PERMIT issued by the DEPARTMENT.

6. With respect to any activities authorized by PERMIT, when the GOVERNMENTAL AGENCY requires insurance on its own or its contractor's behalf it shall also require that such policy include as named insured the State of Michigan, the Transportation Commission, the DEPARTMENT, and all officers, agents, and employees thereof and those governmental bodies performing permit activities for the DEPARTMENT and all officers, agents, and employees thereof, pursuant to a maintenance contract.

7. The incorporation by the DEPARTMENT of this resolution as part of a PERMIT does not prevent the DEPARTMENT from requiring additional performance security or insurance before issuance of a PERMIT.

8. This resolution shall continue in force from this date until cancelled by the GOVERNMENTAL AGENCY or the DEPARTMENT with no less than thirty (30) days prior written notice provided to the other party. It will not be cancelled or otherwise terminated by the GOVERNMENTAL AGENCY with regard to any PERMIT which has already been issued or activity which has already been undertaken.

BE IT FURTHER RESOLVED, that the following position(s) are authorized to apply to the Michigan Department of Transportation for the necessary permit to work within State Highway Right of Way on behalf of the GOVERNMENTAL AGENCY:

Justification:

July 19, 2016, two-year bids were received for an annual supply of Class II Sand (20,000 tons) used by Maintenance and Service Division to backfill streets and restore grass areas disturbed by water or sewer excavations. Two (2) vendors submitted bids with Rodney Woods Builders being awarded the Class II back fill sand for the combined two year low bid.

To date the City has received approximately 5,810 tons (\$34,850) worth of Class II sand from Rodney Woods Builder. Rodney Woods Builder was recently disqualified as a bidder, and it is necessary to accept the second lowest bid.

Manager's Recommendation:

I recommend ratification of a payment to Etna Supply Company of Grand Rapids, MI, a sole source, in the amount of \$2,250 for preventative maintenance for the Instrumentation and Process Controls Division.

Justification:

The Tower Gateway Base Stations (TGB's) that collect the meter reading data for our Sensus Flexnet meter reading system were installed approximately five years ago. A warranty replacement of the air conditioning motors installed on the cabinets that house the TGB's was needed. While on site on November 8, 2016 to address the warranty issue, Etna offered to perform preventative maintenance on all three of the TGB's at a reduced cost. The savings was half the regular cost of the service. In order to take advantage of the reduction, Etna was allowed to perform the preventative maintenance work, which included testing the antenna and base systems; respectively, inspecting and/or confirming proper software installation, power output, receiver sensitivity and other parameters. A complete report with updated site photos was also provided.

Manager's Recommendation:

I recommend that the low bid from Standard Electric of Saginaw, MI be accepted and that a purchase order be issued to them in the amount of \$22,989.60 for the purchase of the fixtures and fittings needed to convert 72 lighting units at the Wastewater Treatment Plant from high pressure sodium and florescent to L.E.D.

Justification:

Due to the size of the site and the necessity of twenty four hour operation there are a large number of lighting units at the Wastewater Treatment Plant which are operated by photo eyes as well as indoor lighting used 24 hours a day. In 2015 all roadway lighting was converted to LED's. The items budgeted for replacement this year include wall pack lighting mounted on the side of the buildings and flood lights at each of the 12 clarifiers which are currently high pressure sodium activated by photo eyes plus twenty florescent fixtures in the administration building. This project covers only the lighting units, all labor will be done by plant personnel. Funds will be budgeted in the coming years to also convert Remote Facilities. On November 15, 2016, sealed bids were opened to provide the fixtures and fittings needed to convert lighting units from high pressure sodium and florescent to L.E.D. The Consumers Energy rebate for this project is estimated at \$3,561.60 and the simple payback in terms of energy savings is estimated to be 40 months. Bid results were as follows:

Standard Electric Saginaw, MI (out-city)	\$22,989.60

Marshall Campbell Saginaw, MI (in-city)	\$24,430.00
