Please be advised that the Board of Trustees of the Saginaw-Midland Municipal Water Supply Corporation, at their regular meeting this date have approved the 2015-2016 Operating, Capital Improvement, and Debt Service Budgets for the Corporation.

In accordance with the 1946 agreement between the City of Saginaw and the City of Midland, it is necessary for capital improvement expense to be additionally approved by the governing bodies of both owner Cities.

The Management and Board of Trustees of the Saginaw-Midland Municipal Water Supply Corporation; therefore, recommend that the City of Saginaw approve the capital expenditure items as shown on the attached Budget for Capital Improvement and Emergency Repair Fund in the amount of \$181,000 for the 2015-2016 budget year, with a fund income allocation set at \$.0125 per 1,000 gallons pumped.

Subject: Donation of Automated External Defibrillator Unit from Pulse 3 Foundation

Manager's Recommendation:

I recommend the acceptance and approval of the donation of an automated external defibrillator (AED) unit from the Pulse 3 Foundation, valued at approximately \$1,500. This lifesaving unit will be installed at City Hall on the first floor to be used in emergency situations.

Justification:

The City of Saginaw submitted an application to the Pulse 3 Foundation for an AED unit on February 17, 2015. The submission of this application was approved by City Council in a motion made by Mayor Pro Tem O'Neal on February 16, 2015. This unit was provided from the Pulse 3 Foundation through the proceeds raised from Shocks & Saves®, a charity hockey game organized in partnership with Mobile Medical Response, the Saginaw Spirit and Detroit Red Wing Jiri Fischer, a sudden cardiac arrest survivor. This lifesaving unit will be installed at City Hall on the first floor to be used in emergency situations.

AEDs make it possible for more people to respond to a medical emergency where defibrillation is required. AEDs should be part of emergency response programs that also include rapid use of 9-1-1 and prompt delivery of cardio pulmonary resuscitation (CPR). All three of these activities are vital to improving survival from cardiac arrest. When trained personnel use an AED and administer CPR within the first few minutes of a victim's collapse, the victim's chances of survival increase dramatically. City Hall is a public building open for business from 8:00 am to 5:00 pm Monday through Friday, and also the location for many public meetings held in the evenings. In addition to City employees, thousands of residents, business owners, and community stakeholders come to City Hall on a weekly basis. City Hall does not currently have a lifesaving AED unit on site.

As stated in the grant application, the City of Saginaw agrees to mount and maintain the unit in an easily accessible location and to train on emergency procedures related to AED use. Robert Weaver of the Fire Department, who is also a certified Basic Life Support instructor with the American Red Cross, has been designated as the AED coordinator for the City. The City Manager's office will work with Firefighter Weaver to coordinate the training of City Hall employees on the AED use.

Manager's Recommendation:

It is recommended the State bid be accepted and that a purchase order be approved and issued to Kustom Signals, Inc. of Lenexa, KS, in the amount of \$6,156 for the purchase of four (4) new Raptor RP-1 Dual K-Band Radar units at \$1,539 each for the Police Department.

Justification:

The Saginaw Police Department would like to purchase four (4) new Raptor Radars, one for each new police vehicle. There are several older units (15+ years) at the department in which we are no longer able to obtain parts and are overdue for replacement. These devices are used for speed measurement and quickly acquire targets at great ranges. Directional capability allows our police officers to monitor vehicles approaching or receding. Raptor Radars are used by police officers around the world and provide the performance needed for agency success. Kustom Signals, Inc. was awarded the State bid contract to provide these radars for all police agencies in the State of Michigan.

This vendor meets all requirements of §14.23, "Vendors," of "Purchasing, Contracting, and Selling Procedure," of Chapter 14, "Finance and Purchasing," of Title I, "General Provisions" of the Saginaw Code of Ordinances O-1.

Funds for this purchase are available in the Community Public Safety – Police Capital Outlay/Less Than \$5,000 Account No. 101-3514-971.000 in the amount of \$6,156 pursuant to the State bid.

I recommend that the Grass Cutting Services Agreement with the Saginaw County Land Bank Authority be approved. The term of the Agreement is from May 5, 2015 through July 31, 2015. In addition, the amount of the Agreement is \$45,000. The Agreement has been approved by me as to substance and the City Attorney as to form. I further recommend that the Director of Public Services or his designee be authorized to sign the Agreement and any other related documents.

It is also recommended that a budget adjustment be completed to increase the General Fund – Saginaw County Account No. 101-0000-674-003 from \$45,000 to \$75,000, an increase of \$30,000. This increase in revenues will be offset by an increase in the General Fund –Department of Public Services - Abatement of Nuisances Division's, Employment Agency Fees Account No. 101-7571-804.000 by \$30,000 in Fiscal Year 2015. The remaining portion of \$15,000 will be budgeted in the same amount and same accounts as shown above in Fiscal Year 2016.

Justification:

The SCLBA has collaborated with the City of Saginaw since 2010 to provide grass cutting services for SCLBA vacant properties. Based upon the City's prior performance, the parties have agreed to enter into this Agreement for the City to provide services for the beginning of the 2015 grass cutting season (May 5, 2015 through July 31, 2015). Specifically, the City will provide grass cutting services for cutting the right of way's and corner clearances for properties abutting City of Saginaw streets. The additional monies will allow the City of Saginaw to hire five temporary employees in order to provide five two-man grass cutting crews for the beginning of the season. In addition, the City will prepare and provide reports to the SCLBA regarding its grass cutting activities. The season historically begins the middle of April and ends October 31, depending on the weather.

Manager's Recommendation:

I recommend that the agreement between the City of Saginaw and Spicer Group be accepted and that a purchase order be approved and issued to them in the amount of \$134,323. The agreement has been approved by me as to substance and the City Attorney as to form.

Justification:

The Saginaw County Road Commission plans to conduct road reconstruction on Davis Road in Saginaw County, Kochville Township, between Pierce and Tittabawassee Roads in calendar year 2018. This work will directly impact our raw 48" and finished 36" water transmission mains. The mains are located in the road right of way and have minimal cover.

The City solicited technical and cost proposals "Invitation Only" using the "Qualifications Based Selection Process" from thirteen engineering firms experienced in the multi-disciplinary areas necessary. On February 6, 2015, the City received proposals from five firms/teams to conduct an evaluation of the conditions that exist and make initial recommendations for solutions that will provide the most appropriate approach for reliability, feasibility, and value. A panel of City officials reviewed and evaluated the qualifications submitted from each firm/team. The panel ranked each firm/team using the City's Qualifications Based Selection criteria listed in Administrative Regulation No. 4-7, Section 1-4. The three highest-ranking firms/teams were invited to an interview. On March 2 & 3, 2015, the City interviewed three firms/teams. The firms/teams were scored individually by the panel members. On March 3, 2015, the panel met to discuss their individual rankings and the Spicer Group/Tetra Tech Team received the highest overall ranking. On March 5, 2015, a memo was sent to all firms interviewed stating that the City would be entering into negotiations with the Spicer Group/Tetra Tech Team. Over the course of several weeks, the scope of work and terms of the agreement have been negotiated.

I recommend that the agreement between the City of Saginaw and Tetra Tech be accepted and a purchase order be approved and issued to them in the amount of \$24,266 to perform a preliminary engineering study to identify the size and type of generator and electrical modifications required at each of the City's seven Retention and Treatment Basins in order to supply emergency power. The agreement has been approved by me as to substance and the City Attorney as to form.

Justification:

The Wastewater Treatment Plant has seven Retention and Treatment Basins to provide treatment of flows in excess of the Wastewater Treatment Plant's capacity. All of the basins were built with two separate power feeds to provide reliability. During the last five years, Consumers Energy has begun to charge the city a fee to maintain these two feeds, making generators a cost effective alternative. On February 9, 2015, the City opened Request for Proposals from two firms and the team of Tetra Tech and Spicer Engineering was scored as the best proposal by the review panel. A follow up interview was held with representatives from the City, Tetra Tech, and Spicer Engineering. During the interview it was determined that the best course of action was to complete the preliminary study and then request a proposal for design and construction engineering.

On March 2, 2015, we received a quote from Hydrodynamics, Inc. in the amount of \$9,604.79 for the impeller and wear ring needed to repair this pump. Hydrodynamics is the local representative for ABBA Pump Parts Co. and a sole source for these parts.

I recommend that the agreement between the City of Saginaw and Greeley and Hansen be accepted and a purchase order be approved and issued to them in an amount not to exceed \$1,367,098, to provide an Asset Management Plan and develop an Asset Management Program for the City's Wastewater Treatment and Collection Systems. These costs will be reimbursed with grant funds through the Michigan Department of Environmental Quality's Stormwater and Wastewater Asset Management Program (SAW) to the City of Saginaw. The agreement has been approved by me as to substance and the City Attorney as to form.

Justification:

In November of 2013, City Council passed a resolution authorizing the Department of Water and Wastewater Services to apply for a grant through the Michigan Department of Environmental Quality's Stormwater and Wastewater Asset Management Program (SAW), and appointing Kimberly Mason (Director of Water and Wastewater Services) as the City's Authorized Representative. On November 12, 2014, the City was awarded a grant in the amount of \$1,999,943 through the SAW Grant program. Funds through this grant are to be used to identify, assess the condition of, assign a criticality to, and develop a financial plan to maintain all of the City's assets related to wastewater treatment, wastewater collection, wastewater pumping stations, and retention and treatment basins. In February of 2014, the City received three proposals to provide an asset management plan and work with City staff to develop an asset management program. The proposals were reviewed, and evaluated by a Review Panel made up of; Kimberly Mason (Director of Water and Wastewater Services), Phil Karwat (Director of Public Services), Paul Reinsch (Superintendent of Water Treatment and Field Operations), Brian Baldwin (Superintendent of Wastewater Treatment), and Andy Biddle (Wastewater Treatment Engineer). All three firms were then invited to make a presentation and be interviewed by the Review Panel. The Review Panel evaluated, scored, and ranked each firm based on their presentation and interview. As a result of this process, the Review Panel selected Greeley and Hansen, the highest ranking firm.
