This material will be stockpiled and will be used in laying additional gravel base to cemeteries roadways and expanding new roadways at Forest Lawn.

The City of Saginaw is working together with other local government in order to place the material, which would equate to a substantial savings. However, the City may have additional costs for grading the crushed stone by needing to hire the services of a bulldozer/operator due to some restricted areas within parts of the cemeteries such as low hanging tree canopies and narrow roadways that the large Road Grader would not be able to maneuver around.

This purchase is for 3,250 tons of gravel to be spread over 2.5 miles of existing gravel roads at the City of Saginaw Cemeteries. Road maintenance has not been done at any of the City's Cemeteries in over 20 years. Many of the roads have deteriorated to the point where portions of these roadways at times are impassable. This purchase will also help alleviate some burden on the existing staff as it relates to cemetery maintenance from poor roadway conditions.

Justification:

On February 6, 1996, City Council approved a procedure for repairing traffic signal controller equipment. City staff does routine repair and maintenance of these solid-state devices. Carrier & Gable, Inc. is Michigan's authorized service representative and offers standard pricing for each type of repair. After sufficient experience with repairing these devices, City staff estimates annual cost for such services is \$6,000. Since this service is necessary to properly maintain the City's traffic signal system, and because Carrier & Gable, Inc. is the only authorized service representative in the region, it is in the best interest of the City to continue this procedure from July 1, 2016 through June 30, 2017.

Manager's Recommendation:

I recommend that the low bid from George Instrument Co. of Royal Oak, MI be accepted and that a purchase order be issued to them in the amount of \$5,925.00 for the purchase of five radar level detection units for use in the Remote Facilities Division for chlorine tank level monitoring.

Justification:

The City operates seven Retention and Treatment Basins. Each one of these locations has a minimum of two liquid chlorine tanks. Level in these tanks must be continuously monitored to insure adequate supply is maintained to disinfect wastewater prior to discharge. Level in these tanks is currently monitored with bubbler systems which require a compressed air supply. The City recently abandoned the use of air actuated diaphragm pumps and installed gravity feed chlorine systems. Installing radar level meters will eliminate the need for air compressors. This will provide savings in both utility costs and in air compressor maintenance costs. More of these units will be ordered in FY2017 to complete the project. On May 24, 2016, sealed bids were opened and the results were as follows:

AN ORDINANCE TO AMEND §151.110 "SCOPE," §151.111 "GENERAL PROVISIONS," §151.113 "COMMENCEMENT OF PROCEEDINGS," §151.114 "NOTICE AND ORDER TO SHOW CAUSE," §151.115 "POSTING OF SIGNS," §151.116 "HEARING OFFICER; HEARING; TESTIMONY; ORDER; NON-APPEARANCE OR NON-COMPLIANCE; COSTS," §151.117 "HOUSING BOARD OF APPEALS/DEMOLITION/REPAIR; COSTS/LEIN ON PROPERTY," §151.118 "JUDICIAL REVIEW," §151.119 "WAIVER PROVISION," §151.120 "EMERGENCY CASES," §151.121 "PENALTIES," AND §151.134 "APPEALS PROCEDURE," OF CHAPTER 151 "HOUSING REGULATIONS," TITLE XV "LAND USAGE," OF THE CITY OF SAGINAW CODE OF ORDINANCES, O-1.

The City of Saginaw ordains:

That §151.110 "Scope," §151.111 "General Provisions," §151.113 "Commencement of Proceedings," §151.114 "Notice and Order to Show Cause," §151.115 "Posting of Signs," §151.116 "Hearing Officer; Hearing; Testimony; Order; Non-Appearance or Non-Compliance; Costs," §151.117 "Housing Board Of Appeals/Demolitions/Repair; Costs/Lein On Property," §151.118 "Judicial Review," §151.119 "Waiver Provision," §151.120 "Emergency Cases," §151.121 "Penalties," and §151.134 "Appeals Procedure," of Chapter 151 "Housing Regulations," Title XV "Land Usage," of the City of Saginaw Code of Ordinances, O-1, are each hereby amended to read as follows:

§ 151.110 SCOPE.

It is unlawful for any owner or agent thereof to keep or maintain any building or part thereof which is a dangerous building. The City does establish this subchapter to govern the abatement of dangerous buildings, structures, or parts thereof, to establish procedures to determine if a building, structure, or part thereof is dangerous, to provide for review, notice and due process in the actions involved with such buildings, structures, or parts thereof. The "Ordinance for the Abatement of Dangerous Buildings, Structures, or Parts Thereof," thereafter also referred to as "this subchapter" is hereby adopted by the City.

§ 151.111 GENERAL PROVISIONS.

For the purposes of this subchapter **DANGEROUS BUILDING** means any building or structure which has any of the defects or is in any of the conditions hereinafter described:

- (A) Whenever any door, aisle, passageway, stairway, or other means of exit does not conform to the City's approved fire code (i.e. is not sufficient in width or size, or is not so arranged as to provide safe and adequate means of exit in case of

- fire or panic, for all persons housed or assembled therein who would be required to, or might use, such door, aisle, passageway, stairway or other means of exit);
- (B) Whenever any portion of a building or structure has been damaged by fire, wind, flood, deterioration, neglect, abandonment, vandalism, or by any other cause in such manner that the structural strength or stability is appreciably less than it was before the damage and is less than the minimum requirements of State law and/or City ordinance for a new building or structure, purpose or location;
- (C) Whenever any portion of or appurtenance to a building or structure is likely to fall, become detached or dislodged, or to collapse, and thereby injure persons or damage property;
- (D) Whenever any portion of a building or structure has settled to such an extent that walls or other structural portions have materially less resistance to winds than is required by State law or City ordinance in the case of new construction;
- (E) Whenever the building or structure, or any part thereof, because of dilapidation, deterioration, decay, faulty construction, or because of the removal or movement of some portion of the ground necessary for the purpose of supporting such building or structure, or for any other reason, is likely to partially or completely collapse, or some portion of the foundation or underpinning is likely to fall or give way;
- (F) Whenever, for any reason whatsoever, the building or structure, or any portion thereof, is manifestly unsafe for the purpose for which it is used;
- (G) Whenever the building or structure has been so damaged by fire, wind, or flood, or has become so dilapidated or deteriorated, as to become an attractive nuisance to children who might play therein to their danger, afford a harbor for vagrants, criminals or immoral persons, or enable persons to resort thereto for the purpose of committing a nuisance or unlawful or immoral act;
- (H) Whenever a building or structure used or intended to be used for dwelling purposes, including the adjoining grounds, because of dilapidation, decay, damage or faulty construction or arrangement, or otherwise, is unsanitary or unfit for human habitation; is in a condition that the county health officer, or their representative, determines is likely to cause sickness or disease; or is likely to cause injury to the health, safety or general welfare of those living within;
- (I) Whenever any building or structure is vacant, dilapidated, and open at door, window or other opening, leaving the interior of the building exposed to the elements or accessible to entrance by trespassers;
- (J) Whenever any swimming pool is permitted:
- (1) To become stagnant;
 - (2) To become a breeding ground for mosquitoes, or other insects;
 - (3) To become algae ridden;
 - (4) To become otherwise unsafe for the intended purposes; or
 - (5) To have the required enclosure surrounding the swimming pool either not properly constructed or maintained in accordance with the requirements of the City.
- (K) Whenever a building or structure remains unoccupied for a period of one hundred eighty (180) consecutive days or longer and is not listed as being

available for sale, lease or rent with a real estate broker licensed under the Occupational Code, MCL 339.2401 through 339.2518, as amended. For purposes of this subdivision, **BUILDING OR STRUCTURE** includes, but is not limited to, a commercial building or structure. This subdivision does not apply to the following:

- (1) A building or structure as to which the owner or agent does both of the following:
 - (a) Notifies the Police Department that the building or structure will remain unoccupied for a period of one hundred eighty (180) consecutive days. The notice shall be given to the Police Department by the owner or agent not more than thirty (30) days after the building or structure becomes unoccupied; and
 - (b) Maintains the exterior of the building or structure and adjoining grounds in accordance with State law and/or City ordinance.
- (2) A secondary dwelling of the owner that is regularly unoccupied for a period of one hundred eighty (180) days or longer each year, if the owner notifies the Police Department that the dwelling will remain unoccupied for a period of one hundred eighty (180) consecutive days or more each year. An owner who has given the notice prescribed by this subsection shall notify the Police Department not more than thirty (30) days after the dwelling no longer qualifies for this exception. As used in this subsection, **SECONDARY DWELLING** means a dwelling such as a vacation home, hunting cabin, or summer home that is occupied by the owner or a member of the owner's family during part of the year.

§ 151.112 DANGEROUS BUILDINGS AS PUBLIC NUISANCES.

All such dangerous buildings or structures are hereby determined to be public nuisances and shall be abated by alteration, repair or rehabilitation, or by demolition and removal in accordance with the procedures specified elsewhere in this subchapter. Further, no owner or agent thereof shall keep, maintain or allow occupancy of any such dangerous building or structure.

§ 151.113 COMMENCEMENT OF PROCEEDINGS.

The Chief Inspector, or their designee, shall examine or cause to be examined every building, structure or portion thereof reported as unsafe or damaged, and if such is found to be a dangerous building as defined in this subchapter, he or she shall commence proceedings to cause the alteration, repair or rehabilitation, or the demolition and removal of the building, structure or portion thereof.

§ 151.114 NOTICE AND ORDER TO SHOW CAUSE.

(A)

- (1) The Chief Inspector shall issue a Notice of Defects in writing to the owner of record or agent of the building or structure stating the defects thereof.

This Notice of Defects shall include a time and place of a hearing on whether the building or structure is a dangerous building.

(a) If the building or structure is a multiple dwelling or rooming house containing units offered to let for more than 6 months of a calendar year, all notices under this subchapter shall also be served upon the lessee, if known.

(A) Service of the Notice shall be made upon the owner or owner's agent. Determination of ownership shall be as indicated by the records of the Register of Deeds for Saginaw County and the records of the City of Saginaw's Assessor. Service shall be on owner or agent thereof by any of the following methods:

(1) Personally delivering a copy to the owner or agent thereof; or

(2) Mailing a copy by certified mail, postage paid, return receipt requested, to the owner or agent and posting a copy thereof upon a conspicuous part of the building or structure.

(B) Notice shall be effective upon the earliest occurrence of any of the following:

(1) Personal service upon the owner or the owner's agent.

(2) The date of mailing by certified mail when a signed return receipt is received.

(C) The Notice shall be served upon the owner or agent at least 10 days before the date of the hearing included in the notice.

§ 151.115 HEARING OFFICER; HEARING; TESTIMONY; ORDER; NON-APPEARANCE OR NON-COMPLIANCE; COSTS.

(A) The Mayor shall appoint a Hearing Officer to conduct a public hearing at which the owner shall be granted an opportunity to show cause why the hearing officer should not order the building or structure be demolished or otherwise made safe and properly maintained. The Hearing Officer may not be the City Manager or any officer or employee of the City. The Hearing Officer shall be a person who has expertise in housing matters.

(B) In any proceedings under this section, the Hearing Officer has the power to administer oaths and affirmations and to certify official acts. The Hearing Officer shall proceed with reasonable dispatch to conclude any matter before him or her. Due regard shall be shown for the convenience and necessity of the parties and their representatives.

(C) The Hearing Officer shall cause a record of the entire proceeding to be made by tape recording or by other means of permanent recording determined appropriate by the Hearing Officer. A transcript of the proceedings or copy of the recording shall be made available to all parties upon request and upon payment of a fee prescribed therefor. The fee may be established by the Hearing Officer but shall not be greater than the cost of making the transcript.

(D) The hearing need not be conducted according to the technical rules of evidence adopted for the Courts of Record in the State of Michigan.

(1) The Hearing Officer shall take testimony from the Chief Inspector, or their representative, the owner of the property and any interested person. Oral

evidence shall be taken only upon oath or affirmation of the party offering the testimony.

- (2) Hearsay evidence may be used under the following guidelines:
 - (a) Hearsay evidence may be used to explain other direct evidence.
 - (b) Hearsay evidence may be used to support other direct evidence.
 - (c) Hearsay evidence shall not be used in itself to support a finding, unless it would be admissible in civil action in courts of competent jurisdiction.
- (3) Any relevant evidence shall be admitted. Relevant evidence shall be defined, for the purposes of this section, as the type of evidence upon which responsible persons are accustomed to rely in the conduct of serious affairs. Such relevant evidence shall be admitted regardless of whether or not it may be admissible in civil actions in courts of competent jurisdiction.
- (4) Irrelevant and unduly repetitious evidence shall be excluded.
- (E) Each party shall have these rights:
 - (1) To call and examine witnesses on any matter relevant to the issues of the hearing;
 - (2) To introduce documentary and physical evidence;
 - (3) To cross-examine opposing witnesses on any matter relevant to the issues of the hearing;
 - (4) To impeach any witness regardless of which party first called the witness to testify;
 - (5) To refute the evidence;
 - (6) To represent himself or herself or to be represented by anyone of his or her choice who is lawfully permitted to do so; and
 - (7) To make a closing statement at the conclusion of the evidentiary portion of the hearing.
- (F) Failure of the owner or his representative to appear at the hearing may be deemed to be an admission by the owner that the building or structure, or part thereof, that is the subject of the hearing is a dangerous building. Consideration shall be given to the following when rendering a decision:
 - (1) The evidence presented;
 - (2) The condition of the building or structure as a whole;
 - (3) The extent of the deterioration of the building or structure;
 - (4) The cost of demolishing the building or structure;
 - (5) The cost of making the building or structure safe;
 - (6) Whether a reasonable person exercising prudent business judgement would determine the cost of making the building or structure safe would exceed the market value of the structure after the repairs were completed;
 - (7) Whether there are any conflicts with other ordinances, State laws or Federal statutes;
 - (8) The effect the completion of the demolition and removal or of making the building or structure safe would have upon the health, safety and welfare of the area immediately surrounding the building or structure in question; and

- (9) Whether actual substantial progress has been made by the owner to make the building safe. In determining whether substantial progress has been made, the Hearing Officer considers such factors as whether a building permit has been obtained relative to the repairs, whether the owner has contracted for necessary materials or services, and the extent to which the repairs or demolition has progressed.
- (G) At the conclusion of the hearing, the Hearing Officer shall make written findings of fact based upon the competent evidence and testimony admitted during the hearing. If applicable, the Hearing Officer may conduct an on-site inspection of the building or structure.
- (H) Not more than 5 business days after completion of the hearing, the Hearing Officer shall render a decision either closing the proceedings or determining that the building is a dangerous building. He or she shall then order the building or structure to be demolished or made safe and properly maintained, as the facts determined by the Hearing Officer shall dictate. The Hearing Officer shall fix a time by which the owner of the building or structure shall complete the demolition or make the building or structure safe and properly maintained. The Hearing Officer's Notice of Findings and Order shall be given to the owner in the manner set forth in this subchapter. The effective date of the Hearing Officer's Notice of Findings and Order shall be upon service as provided in this subchapter.
- (I) The authority of the Hearing Officer ceases upon the service of the Hearing Officer's Notice of Findings and Order as set forth in this subchapter. Upon such service, the Hearing Officer shall have no authority to reverse his decision, to grant an extension of time, or to entertain a request to reopen the hearing or to grant any other request of the owner or the owner's agent. Each written Notice of Findings and Order of the Hearing Officer shall contain a statement advising the owner, or the owner's agent, of the limitations of the Hearing Officer as set forth in this section.

§ 151.117 HOUSING BOARD OF APPEALS/DEMOLITION/REPAIR; COSTS/LIEN ON PROPERTY.

- (A) If the owner or agent fails to appear or neglects to comply with the Hearing Officer's decision and order, the hearing officer shall file a report of the findings and a copy of the order with the City Inspector not more than 5 days after the date for compliance set in the order and request that the necessary action be taken to enforce the order. A copy of the Hearing Officer's Notice of Findings and Order and request that necessary action be taken to enforce the order shall also be filed with the Housing Board of Appeals.
- (B) The Housing Board of Appeals shall set a date not less than 30 days after the initial hearing for a hearing on the findings and order of the Hearing Officer. The Housing Board of Appeals shall give notice to the owner or agent of the time and place for the hearing as set forth herein. At the hearing, the owner or agent shall be given the opportunity to show cause why the order should not be enforced. The Housing Board of Appeals shall approve, disapprove, or modify the order.

- (C) If the Housing Board of Appeals approves or modifies the order, the City Inspector, or his or her designee, shall take all necessary action to enforce the order. If the order is approved or modified, the owner or agent shall comply with the order within 60 days after the date of the Housing Board of Appeals' hearing.
- (D) If the building or structure has been substantially destroyed by fire, wind, flood, deterioration, neglect, abandonment, vandalism, or other cause, and the cost of repair of the building or structure will be greater than the state equalized value of the building or structure, the Housing Board of Appeals shall issue an order of demolition. The owner or agent shall comply with the order of demolition within 21 days after the date of the Housing Board of Appeals' hearing.
- (E) The cost of demolition, making the building safe, or maintaining the property includes, but is not limited to, the costs of serving notices, fees paid to hearing officers, costs of title searches or commitments used to determine the parties in interest, recording fees for notices and liens filed with the county register of deeds, demolition and dumping charges, court reporter fees, and costs of the collection of the charges authorized herein. The cost of the demolition, making the building safe, or of maintaining the exterior of the building or structure, or grounds adjoining the building or structure incurred by the City to bring the property into conformance with this subchapter shall be reimbursed to the City by the owner or party in interest in whose name the property appears. This includes owners who have an interest when these proceedings commence or who acquire their interest during the pendency of the proceedings.
- (F) The owner in whose name the property appears upon the last local tax assessment records and within the records of the Register of Deeds shall be notified of the amount of such cost by first class mail at the address shown on the records. If the owner fails to pay the same within thirty (30) days after mailing by the assessor of the notice of the amount thereof, the City shall have a lien for the cost incurred by the City to bring the property into conformance with this subchapter. The lien shall not take effect until notice of the lien has been filed or recorded as provided by law. A lien provided for in this subsection does not have priority over previously filed or recorded liens and encumbrances. The lien for the cost shall be collected and treated in the same manner as provided for property tax liens under State law.
- (G) In addition to other remedies under this subchapter, the City may bring an action against the owner of the building or structure for the full cost of the demolition, of making the building safe, or of maintaining the exterior of the building or structure or grounds adjoining the building or structure incurred by the City to bring the property into conformance with this subchapter. The City shall have a lien for the amount of the judgment against the owner's interest in all real property located in this state that is owned in whole or in part by the owner of the building or structure against whom the judgment is obtained. The lien provided for in this section shall not take effect until notice of the lien is filed or recorded as provided by law. The lien does not have priority over prior filed or recorded liens and encumbrances. The judgment may be enforced against assets of the owner other than the building or structure.

§ 151.118 JUDICIAL REVIEW.

An owner aggrieved by any decision or order of the Housing Board of Appeals under this subchapter may appeal the decision or order to a court of competent jurisdiction by filing a petition within twenty (20) days from the date of service of the Order.

§ 151.119 WAIVER PROVISION.

The owner of any building or structure, or the owner's agent, may, at any time, admit in writing that such building or structure is a dangerous building within the meaning of this subchapter, and waive notice, a hearing, findings, order and service of the order under this subchapter, and court review of such order. The owner or the owner's agent may consent that such building or structure be demolished and the cost charged against the property. In such event, the Chief Inspector, or their representative, may have said building or structure demolished and the cost charged against said property shall be collected in the same manner as provided for in §33.26.

§ 151.120 EMERGENCY CASES.

- (A) In cases where there is evidence of an immediate and serious danger to the public safety or health unless a dangerous building or structure as defined in this subchapter is immediately demolished or otherwise made safe, the Chief Inspector, or their designee, may cause the immediate repair or demolition of such dangerous building or structure. Determination of immediate and serious danger to the public safety or health shall be determined by the Chief Inspector, or their designee, including but not limited to the City Fire Marshal. The determination of an immediate and serious danger includes, but is not limited to, situations which may lead to the immediate potential for injury, death, spread of disease or infection, or for property or structural damage which indicates an immediate and serious danger to the public safety or health. The potential for harm to emergency personnel who may have to re-enter such structures in the course of their duties may be considered when determining an immediate and serious danger to public safety or health exists. The costs of such emergency repair or demolition shall be collected in the manner as provided for in § 33.26.
- (B) Written notice shall be provided to the owner or agent of the property on which the emergency case existed as soon as practicable after the dangerous building or structure has been demolished or otherwise made safe. At a minimum, the written notice will detail what action was taken by the City, why such action was necessary, and the date of such action.
- (C) If the emergency case requires more than twenty-four hours to remedy, the City shall obtain the permission of the owner or agent of the property to continue entry onto the property, and such contact shall be documented, and/or the City shall obtain a court order authorizing continued entry.

§ 151.121 PENALTIES.

A person or persons who fail or refuse to comply with an order approved or modified under this subchapter within the time period mandated by such an order is guilty of a misdemeanor, punishable by imprisonment for not more than one hundred twenty (120) days, or a fine of not more than one thousand dollars (\$1,000.00), or both.

§ 151.122 CONFLICTING ORDINANCES.

All previous ordinances or sections thereof pertaining to the abatement of dangerous buildings which may be in conflict with these provisions of this subchapter are hereby repealed except as hereinafter otherwise provided. Said repealed ordinances or sections thereof shall remain in full force and effect as to all actions commenced ongoing prior to the effective date of this subchapter.

§ 151.123 PROCEEDINGS PENDING.

All proceedings pending and all rights and liabilities existing, acquired or incurred under any ordinances hereby repealed at the time this subchapter takes effect, are hereby retained, and such proceedings may be consummated under and according to the ordinance in force at the time such proceedings are or were commenced. It is the intent that this subchapter shall not be construed to alter, affect, or abate any pending prosecution or prevent prosecution hereinafter instituted under such ordinances or any section thereof for offenses committed prior to the effective date of this subchapter, and all prosecutions instituted after the effective date of this subchapter for offenses committed prior to the effective date of this subchapter or for work conducted prior to the effective date hereof, may be continued or instituted under and in accordance with the provisions of the ordinance or sections thereof in force at the time of the commission of such offense.

§ 151.134 APPEALS PROCEDURE.

(A) *Appeals procedure.* Any person affected by any notice of violation(s) which has been issued under this chapter may request and shall be granted a hearing on the matter before the Housing Board of Appeals, as established by §12.14 of the code. The affected person shall file a written appeal in the office of the Chief Inspector requesting the hearing. The appeal shall include the name, address and phone number of the appellant and a brief statement of the grounds for the hearing. The appeal shall be filed within twenty-one (21) days after the day the notice of violation or order is served. Failure to file the written notice of appeal within the twenty-one (21) day period shall be deemed a waiver of the person's right to a hearing or to otherwise contest the notice of violation(s) or order. Upon timely receipt of an appeal, the Chief Inspector shall set a time for a hearing before the Housing Board of Appeals and shall give the appellant written notice of the date, time and location for the hearing.

(B) *Hearings.* Hearings shall be commenced within a reasonable time after an appeal has been filed. At such hearings the appellant shall be given an opportunity to be heard and to show cause why the notice of violation or order should be modified or withdrawn. Such hearings shall be open to the public.

(C) *Decisions and powers of Housing Board of Appeals.*

- (1) After a hearing, the Housing Board of Appeals may sustain, modify, or withdraw the notice of violation or order depending upon its findings. In rendering these determinations, the powers of the Housing Board of Appeals shall be strictly limited to making interpretation of the provisions of this chapter, to the applicability of its specific provisions to the specific case being heard, and to granting variances to the provisions of this chapter. In granting variances, this Board shall be allowed to grant a variance if it clearly appears that, by reason of special condition, undue hardship would result from strict application of any section of this chapter.
- (2) In these cases the Board may permit a variance from mandatory provisions thereof in such a manner that the public safety shall be secured, substantial justice done and the spirit and intent of the provisions of this chapter are upheld. In no case shall this Board grant a variance which would lessen the safety, health and welfare requirements of this chapter. Any variances granted shall be for this chapter and shall not and cannot waive the requirements and provisions of any other applicable code, ordinance, or law. All decisions rendered under this section shall be in writing and shall be final. A copy of the decision shall be mailed to the appellant at the address shown on the appeal.
- (3) The failure of the appellant, or his or her representative, to appear and state his or her case at the hearing shall have the same effect as if no appeal was filed and the Board shall proceed to deny the appeal and affirm the notice of violation or order.

This ordinance shall become effective June 16, 2016.
