REGULAR MEETING OF CITY OF SAGINAW COUNCIL HELD
MONDAY, OCTOBER 11, 2010, 6:30 P.M., COUNCIL CHAMBER, CITY HALL

Approved 9/27/10 council meeting minutes.

Held public hearing on Albee Township Urban Cooperation Agreement.

Reappointed Elsenia L. Porterfield and Emilie R. Truax to the Human Planning Commission with terms to expire 10/11/12.

Appointed Joel Tanner to the Income Tax Board of Review for an indefinite term, Odie Pruitt to the Saginaw Housing Commission to fill a vacancy until 9/8/2013 and Tom Begin for a term to expire 9/18/2015.

Mayor Branch rotated the Boards and Commissions Committee members with Councilman Wendt becoming Committee Chairperson, Councilman Virciglio next in line for Chairperson and Councilman Scharffe as new member.

Issued purchase orders to Ikon Office Solutions, Inc., Novell, Inc., Michigan Office Design, Joseph M. Day Co., Pumps Plus, Inc., Detroit Pump & Mfg., Jack Doheny Supplies and Rapid Water Recovery.

Approved agreements with Ikon Office Solutions, Inc., Cambridge Integrated Services Group, Inc., United Way of Saginaw County, Albee Township (Water Services & Urban Cooperation), Meredith Corporation d/b/a WNEM TV5, Lois Kay Contracting, Maximus, Inc., Rohde Bros. Excavating, Inc., MAP Mechanical, Aleda E. Lutze VA Medical Center and Remer Plumbing, Heating and Air Conditioning, Inc.

Introduced Ordinance amending §90.02, "Permits," §90.05, "False Alarms," §90.06, "False Alarms: Fees," and Paragraph (B) of §90.09, "Defective Alarms," and adding §90.10, "Billing, Collection and Penalties," to Chapter 90, "Alarms" of Title IX, "General Regulations," of the Saginaw Code of Ordinances O-1.

Adopted resolutions to transfer ownership of escrowed 2010 Class C licensed business with Dance-Entertainment Permit, from Evolutions Eateries, Inc., 118 N. Michigan, to Citizens Bank; approving issuance of Hospital Revenue Refunding Bonds; and asserting Council's right to approve or reject the final version of the City of Saginaw Master Plan.

Voted down motion declining Council's right to approve or reject the final version of the City of Saginaw Master Plan.
